
MARINE SAFETY



BRLA APPEALS TOWNSHIP OF RIDEAU LAKES COMMITTEE OF ADJUSTMENT DECISION

On May 27, 2015, the Township's Committee of Adjustment approved Application #A-8-2015, allowing three variances on what must be one of the smallest waterfront lots on Big Rideau Lake (.24 acres). Of particular concern was the Committee's conclusion that an 8 metre setback for the proposed new dwelling would be adequate when a 30 metre setback is the minimum normally required by the Township's Official Plan and Zoning Bylaw. It also reduced the proposed sewage disposal system setback to only 15 metres.

Before the Committee of Adjustment made its decision, it circulated the proposal to the technical agencies for review and comment. The Rideau Waterfront Review Team advised against the reduction and concluded that the soil, slope and vegetation conditions warranted a 40 metre setback! The Committee of Adjustment ignored this recommendation.

Several delegations appeared at the Committee of Adjustment hearings on this matter, including BRLA representatives. Only the applicant spoke in favour.

The Committee voted 4 to 2 to approve the application. Voting in favour were Mayor Ron Holman, Ron Pollard (North Crosby), Arie Hoogenboom (South Elmsley) and Cathy Monck (Newboro). Voting against were Cathy Livingston (Bastard & South Burgess) and Linda Carr (South Crosby).

The recently completed Rideau Lakes Sub-watershed Report 2014 is a "report card" on the current condition of the upper watershed.

These updates are completed every five years. It reveals continuing challenges to the environmental health of these lakes. Big Rideau is better off than Upper Rideau and Lower Rideau but care is needed in the way development and redevelopment is carried out if the lakes are to receive the protection they deserve.

The BRLA Board voted unanimously to appeal the Committee of Adjustment decision to the Ontario Municipal Board (OMB). It did not make this decision lightly. Nor does the Board plan to make a habit of this. The Board supports good development and redevelopment which minimizes impacts on the lake. But sometimes, a lot is just too small to adequately support residential development. This is one of them.

The local press has reported that Township representatives see nothing wrong with this Committee of Adjustment decision and plan to spend your tax dollars to support it at the OMB. If the decision is allowed to stand, we can probably expect more decisions like it, anywhere in the Township.

A number of concerned lake residents have already expressed their support for the action taken by BRLA and have made cash donations to RLEF to help pay for this appeal. Additional support is welcomed, as soon as possible. Please identify your donation as a contribution to the lake defence fund.

BRLA TREASURER'S REPORT

2014

We finished the 2014 fiscal year with a disappointing, but not surprising, \$6,739 shortfall, with expenditures exceeding revenue, and a correspondingly weaker balance sheet.

Our 2014 records have been audited, financial statements have been accepted and issued and the 2014 tax return has been filed with and assessed by the CRA.

As stated at the AGM on July 4th, the current year has improved modestly from last year but we do continue to deal with funding, revenue and expense challenges.

The current year to date numbers compared to the same date last year, show an improving Profit & Loss as we have reduced expenses and our membership drive has brought members back in to the Association after several years of absence.

Because we do not have final bills for shoal markers removal after Thanksgiving and the remainder of taxes on Cow Island, it is hard to forecast our expected year end position.

My best estimate is that we're likely to see another shortfall this year, hopefully not in excess of \$4,000.

Again, I must assure everyone that while challenges continue, your BRLA is not at risk of insolvency or even of failing to meet its immediate obligations.

The new Board's challenge is to stop the bleeding to reestablish our solid financial heritage.

Finally I do ask for your help in finding a suitable candidate to take over as Treasurer for the balance of the year.


I was floating along the marshlands and notice the big highway 401. It is 6.7 metres high and was built in the late 1950s. It sounds very strange when I was under this

BRLA - DISCOVER WHAT WE ARE AND TELL YOUR NEIGHBOURS

When I joined the Board of the Big Rideau Lake Association 2 years ago, I did not know that this organization provided the shoal markers that are so important to the boaters on this lake. I wonder how many other cottage residents have the same limited perspective on this great community organization.

I bring this to attention because the oldest organization on the Rideau lakes is facing some financial difficulties. Membership has not kept pace with the increase in expenses. Few of the yacht owners are members. The number of boats watching the BRLA Fireworks last year represented about three times the membership. The Fireworks are only supported by federal grants if they occur on Canada Day. Due to the fact that many people tend to be at the lake on weekends much of the season, the Big Rideau Lake Association foots the bill for the total cost. Thankfully a member who is certified to manage such activities volunteers his time.

But how do we reach the members of this widespread community? I like to say the street we all live on is very wide and very wet. The BRLA has an excellent website and publication (Driftwords) but these reach the membership primarily.

My efforts this year will be to attract those who are not members, make them aware of the services and opportunities that we provide, many of which they take advantage of without helping to cover the cost.
